Ant		# 1007-RPM Support, Rotated Base Plate & Contoured Lumbar Pads
1.	Base Plate Pad:a. Attach the double clip side of the Base Plate Pad to the base plateb. Stretch the single clip over the opposite side of the base plate	
2.	The Anterior Support Pad has a top and a bottom and can only be "snapped" on the metal plate in one direction. Seat the top edge of the metal plate into the clip and snap the bottom of the clip over the plate. To Remove: Push the extension wall over the edge of the metal plate.	Extension Wall
3.	The Contoured Lumbar Pad attaches to the Lumbar Support with the VELCRO [®] strip. Note the thick portion of the pad is oriented to the head of the patient.

Anterior Support, Contoured Lumbar Pads

The Anterior Support Pad has two extension walls and can only be "snapped" on the metal plate in one direction. Seat the side edge of the metal plate into the clip and snap the extension wall of the clip over the other side of the plate.

To Remove: Push the Extension Wall over the edge of the metal plate.

The Contoured Lumbar Pad attaches to the Lumbar Support with the VELCRO[®] strip. Note the thick portion of the pad is oriented to the head of the patient.



Adjustable Lateral Support Pad

The Adjustable Lateral Support Pad has a top and a bottom and can only be "snapped" on the metal plate in one direction. Seat the top edge of the metal plate into the clip and snap the bottom of the clip over the plate.

To Remove: Push the Extension Wall over the edge of the metal plate.
